and



1. Purpose & Scope:

The purpose of this Memorandum of Agreement is to set forth the terms and conditions, scope of works and responsibilities of the parties associated with their collaboration on initiating and organising a short duration Certificate Course on Biodiversity and Wildlife. The 'MoU' will remain effective for 3

years and the said Course will be conducted once a year in SCC, Kolkata. The 'MoU' may be extended or revised after every 3 years on mutual discussions between the three Institutes viz. SCC, WBSU and SHER. Initiation of the Certificate Course and the progress thereupon will be reported to the EC and the Court of the WBSU and also to the Internal Management Committee and the Governing Body of SCC on a regular basis.

2. Financial arrangements:

WBSU's responsibility will be confined to deployment of academic resources for the said course without sacrificing its own academic interest. SCC is committed to provide the venue including a lecture hall with necessary infrastructures (including writing/display board, audio-visual projector, wi-fi, continuous power supply, etc) for organising the theory lectures. SHER shall give organisation and management support including lecture day venue managements, contacting and helping the resource persons to conduct the lectures/field training, helping in preparation of resource materials for the participants, organising local field visits for hands on training, as and when required.

1. Terms and conditions:

It is mutually understood and agreed by and between the three Institutes viz. WBSU, SCC and SHER that:

- Detailed modalities of the course will be agreed upon mutually by three parties, i.e. WBSU, SCC and SHER, and record thereof will be kept with all the parties.
- Candidates completing the course will be given certificates duly signed by the WBSU authority and the SCC authority. The record of the successful candidates will be reported to the executive committee of WBSU.
