AGREEMENT FORM FOR ADOPTION OF ANIMALS.

This agreement is made this Fourteenth day of December, Two thousand Twenty Three between The Zoological Garden, Alipore, Kolkata, represented by its Director or the authorized representatives And hereinafter called the First Party of the one part.

AND

Nature Club of Scottish Church College having his permanent address at 1 & 3, Urquhart Square Kolkata- 700006, West Bengal, correspondence address Same as above and his Pan Card No. AAETS5313E Aadhar Card No. 6431 2329 4934 Mobile No. 9830075960 hereinafter called the Second Party of the other part.

WHEREAS a programme for the adoption of animals/birds (Clause 2, rule(1) of WL.PA 1972) has been launched by the First Party and under the said programme any animal or bird housed in the aforementioned Zoological Garden may be adopted by corporate houses or individuals.

AND WHEREAS this programme has been initiated so that people can participate and be involved in the welfare of the animals/birds and their lovers intending to look after the needs and welfare of the animals /birds and may adopt any animal or bird.

AND WHEREAS the Second Party being desirous of adopting an animal/bird has entered into an agreement to adopt an animal/bird with the First Party on the following terms and conditions. :

Now the agreement witnesses:

1. That the Second party shall adopt 1 No. of Chimpanzee, having the stud-Book No.....transponder No, Ring No..... for the year .....commencing from 14/12/2023 to 13/12/2024.

2. That the money required for the cost of adoption of aforementioned animal/bird is being paid by The Second party to the First party vide NEFT/CHEQUE No. dt. 14 /12 / 2023 of Rs 30,000/-only..

3. That the First Party has acknowledged the payment of Rs.30,000/- -by receipt No 18310 dated 20/12/2023.

4. That this agreement for adoption shall remain valid, binding and operative for only the period mentioned above that is from 14/12/2023 to 13/12/2024 and shall commence from the day this agreement is executed.

5. That after the expiry of the agreement period as stipulated, the Second party may enter into a new agreement with the First Party. The rate of the adoption charges or other new provisions, if any, of the agreement shall be decided by the First Party.

6. That this agreement shall not entitle, for any purpose whatsoever, the Second party or his/her family members to feed, touch, handle, fondle or carry any animal/bird outside its enclosure nor shall it entitle the Second party or his/her family members to enter the enclosure of the animal/bird or do such other act which violates the animal laws and wildlife laws of the land.

7. That however the Second Party will be issued an Entry Pass which entitle the Second party and his/her family members (not more than 4 in numbers) to visit the Zoological Garden once every month at a time by informing the Zoo authority and by presenting the same at the main gate on the day and at the time, during visiting hours, specified by Zoo management.

8. That however the Second party shall not insist on visiting the Zoo during non-visiting hours nor shall he/she claim any other facilities and amenities from the First Party apart from those stipulated in this agreement.

9. That he First Party shall put up a board inside/outside the enclosure of the adopted animal/bird exhibiting clearly the name of the Second Party and illustrating that the particular animal/bird has been adopted by him/her for the period from 14/12/2023 to 13/12/2024. The dimension of the board shall be determined by the zoo authority. In case of adoptions of different animals of the same animal species housed in same enclosure the boards may needed to be clubbed together or display arranged accordingly.

10. That the First Party shall also mention the name of the Second Party in Annual Report of the Society and the First Party shall also grant a certificate to the Second Party showing the details of the animal/bird adopted by him/her, and shall be collected by the second party in person.

11. That the Second Party shall not claim any right over the ownership of the adopted animals/bird or any of its offspring or for any part/parts of any animal/bird.

12. That on the death or exchange (with some other zoo) of the adopted animal/bird before the expiry of the stipulated period of the agreement, the money which had initially been paid by the second Party as adoption charge shall be forfeited to the First Party and the Second Party shall not be entitled to claim / get refund of the same nor shall the Second party be entitled to adopt some other animal/bird with the initial adoption charge paid by him/her.

13. That if the Second Party intends to terminate the agreement before the expiry of the period as aforementioned, the Second Party shall give one month's prior notice in writing to the First Party and shall thus be entitled to terminate the agreement. However, in such a case, the Second party shall not be entitled to claim / get refund of the adoption charge paid by the Second party.

14. That the Second Party, shall not, in any way, interfere in the management and administration of the First Party. All management practices rest solely in hands of the First party and all management and administrative decisions shall be taken by the First Party.

15. That in case of any disputes and differences, those should be tried to resolve mutually and amicably as far as possible and practicable. However, unresolved disputes, if any, are subject to the exclusive jurisdiction of the courts in Kolkata, West Bengal.

16. That when an agreement is signed between the Zoological Garden Alipore (first party) and the Adopter (Second party) both the parties to show mutual respect between each other. In case of any dispute the party should not use any derogative or unparliamentary language against the management. If so done the management may terminate the agreement instantly and debare the party from further adoption.
