# AMAR KUTIR SOCIETY FOR RURAL DEVELOPMENT, SHRINIKETAN, BIRBHUM

This document constitutes an agreement between the Scottish Church College(Govt. Sponsored), 1 & 3 Urquhart Square, Kolkata - 700006, India and Amar Kutir Society for Rural Development, P.O. Shriniketan, Dist.-Birbhum, State-West Bengal, PIN-731236, India for promoting Academic development including Enterprenureship Training and Research of both the Institute.

Article 1. **Objective:** The objective of the MOU is to express the willingness of both institutes to engage with the utmost effort to promote the development of Academic activities including Research as well as to expand the academic relationships among the departments of the constituting institutes. The specific academic activities under this MOU will be taken place through a Joint Committee (JC) constituted by the Heads of the Institutions.

**Dr. Madhumanjari Mandal**, The Principal, Scottish Church College(Govt. Sponsored) (here in after abbreviated as SCC and reffered as party I) (which term or expression shall unless excluded by or

repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) agrees to assist Prof. (Dr.) Prashanta Kumar Ghosh, S/O Late Santimoy Ghosh, the Secretary, Amar kutir Society for Rural Development (here in after abbreviated as AKSRD and referred to as party II) (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) to carry out academic Research, Training and enterpreneourship Development in SCC end and whereas the Secretary of AKSRD will reciprocate the same academic and other fields.

The academic criteria include (a) Faculty Exchange Program (b) Hiring expertise for different traing Programme for UG and PG as and where applicable (c) Conducting joint research in the fields of interest to both the parties, (d) Organisation of joint scientific and rural development activities (e) Access to the instruments and equipment, and software available in both institutes as and when applicable (f) Organisation of various student participatory programs like the field visit, workshop, seminar, symposium, internship, short-term diploma, certificate courses etc.

### 2. General Terms and Conditions of MOU:

- Duration of MOU: This MOU shall be operational upon signing and will have an (i) initial duration of three years (03 yrs). All activities conducted before this date within the vision of the collaboration will be deemed to fit under this MOU.
- Coordination: To carry out and fulfill the aims and scopes of this MOU, both (ii) institutes will nominate the Head of the Department (HOD) or authorized Person as a Representative of any committee, as and when required.
- Termination of MOU: The partnership covered by this MOU shall in general (iii) terminate upon completion of the agreed schedule i.e., 3 yrs. However, this Memorandum may be terminated with three month written notice from either end of two parties
- Extension of Agreement: The MOU may be extended by the Heads of the (iv) participating institutions if they agreed to do so.
- Communication and Legal Dispute: All communication under this MOU shall be (v) in English only. Any legal matter should be mitigated in consultation with the Head of the Institutes (Principals/TIC) and observed in Suri Court only.
- Financial Liability: As such there will be no financial liability from the ends of both (vi) parties.
- Addendum: Any addendum in this MOU shall be in writing and signed by the (vii) Heads of the participating parties. The terms and provisions in this MOU also apply to any subsequent Addendum to this agreement.
