WHERE AS, both Parties wish to collaborate and cooperate for betterment of academic facilities and the advancement of education.

NOW, both the parties agree on the following:

OBJECTIVES:

The objectives of this MOU are:

- To promote academic excellence and innovation in education;
- b) To facilitate the sharing of academic resources between the two institutions;
- c) To collaborate in the development of new educational programs and initiatives;
- d) To Share information and expertise in areas of mutual interest.

AREAS OF COOPERATION:

First Party and Second Party will cooperate in the following areas:

- a) Sharing of academic resources such as libraries, laboratories and teaching materials;
 - b) Joint research projects and academic publications;
 - c) Exchange of faculty, staff, and students;
 - d) Joint academic conferences and seminars;
 - e) Collaborative programme development and delivery,
 - f) Add On and Certificate Courses,
 - g) Addressing Environmental Issues jointly,
 - h) Career Counseling and Employability Guidance,
 - i) Games and Sports and Cultural activities.

IMPLEMENTATION:

To implement this MOU, First Party and Second Party will:

- a) Appoint a liaison officer from each institution to facilitate communication and cooperation;
- b) Establish working committees to oversee and implement specific areas of cooperation;
- c) Hold regular meeting to review progress and identify new areas of cooperation;
- d) Collaborate on grant proposals and funding opportunities to support joint projects and initiatives.

DURATION AND TERMINATION:

This MOU shall be effective for a **period of 3 years** from the date of signing. Either party may terminate this MOU upon written notice of one month to the other party.

MODIFICATIONS:

This MOU may be modified or amended at any time by mutual agreement of both parties in writing.
