SCHEDULE TO THE ACCOUNTS FOR THE YEAR ENDED 31ST MARCH 2023

SCHEDULE - "12" NOTES ON ACCOUNT

- Revenue Recognition: Items of Income and Expenditure are generally recognized on accrual basis except certain minor expenditure, which are generally accounted on cash basis as a consistent practice.
- Fixed Assets are stated at cost of acquisition inclusive of freight, duties, taxes, etc on the date of
 acquisition/installation. Depreciation is provided on Fixed Assets on written down value method at the
 rate specified in Income Tax Act, 1961. Fixed Assets Register should be maintained for all fixed assets
 and should be updated every year.
- Investments are classified as Long Term Investments where it is intended to be held for more than one year from the date on which such investment is made. Interest on fixed deposit has been accounted on accrual basis, any variance of interest/principal figure is accounted on maturity of fixed deposit.
- 4. In the opinion of the Management, Current Assets, Loans and Advances, if realized in the ordinary course of business, shall fetch approximately the value at which these have been stated in the books of account and that provisions for all known liabilities are adequate. Further certain old balances required to be reconciled/ adjusted. Further Inter balance reconciliation of various college branches needs to be done as they do not correlate with each other due to old differences.
- All dues relating to PF & ESI is being reimbursed by department to Scottish Church College. Further all
 expenses relating to PF such as administration charges and others including interest is borne by college
 general account.
- 6. Fees received during the year are subject to reconciliation, as it accounted on cash basis.
- Previous year figures have been regrouped, rearranged and reclassified wherever considered necessary to conform to current year's presentation.
